SUBJECT: Classroom Site Fund Allocation

The FY 2011 Classroom Site Fund (CSF) payment calculations were projected to be \$220.00 per weighted attending student count per the Joint Legislative Budget Committee' (JLBC) projections.

School Finance has completed the final FY 2011 CSF payment #8 calculations. Actual receipt of the CSF payment by counties/districts and charters is scheduled for Friday, March 18, 2011.

The report detailing the counts and weights used to determine the Classroom Site Fund allocation will be available on Thursday, March 17, 2011 at http://www.ade.az.gov/districts. Each district and charter will have received a proportionate share of CSF revenues (\$167,479,000.00), based on their proportionate share of state total weighted count. All monies received for the Classroom Site Fund to date have been distributed based on each district's or charter's weighted attending student count.
