YMCA Power Scholars Academy Program Proposal, Summer 2025

The purpose of this partnership between D90 and the West Cook YMCA is to provide a comprehensive summer program for students who have been identified for Tier II academic interventions and would benefit from group remediation strategies. Research indicates that students who have been identified for tiered intervention services are most likely to experience decreased academic growth rates from June to August (often known as "summer slide"). The PSA program is intended to address and counter that phenomenon by engaging students deeply and providing high-growth learning experiences while building academic confidence. The main academic emphasis is on Reading and Math.

The academic component of PSA is complemented by enrichment programming, including modules such as drumming, drama, and visual arts. Students also participate in weekly field trips that encourage attendance and help build students' social emotional competencies. All participants receive no-cost lunch, snack, and breakfast (as needed) and efforts are made to build strong community amongst the students and staff.

Class sizes are kept small to allow for delivery of targeted interventions (both small group and individual, as necessary). Students are pre- and post-tested for academic growth and are delivered a hybridized curriculum containing both BellXcel and D90 content. To focus instruction and gather improved data about student outcomes, we are recommending hosting the program again for qualifying students grades 2-4 for summer 2025. The District will continue to collaborate with the YMCA to investigate additional methods to measure the degree to which participation in the program impacts student achievement.

It is important to note that the PSA partnership with the YMCA evolved in response to a Board of Education Strategic Goal (2020-25), charging the District with enhancing community partnerships. While not related specifically to this PSA proposal, the YMCA/District 90 partnership affords additional benefits to our school community. These include our after-school supervision program (Signature Program), the no-cost "Swim Access Program" to ensure child safety around water, and opportunities for D90 families and staff to participate in several community health and wellness programs on a complimentary basis.

Please find attached the cost proposal for 2025 and a copy of the presentation that was provided for the Board of Education and community at the December Committee of the Whole Meeting. Hopefully this information will be helpful in providing additional background that will allow the Board to support the ongoing delivery of this program in the coming year.






