Background Information:

State Statute requires that change in the Budget adopted by the School Board at their June 2016 meeting (and amended at subsequent meetings) must be approved by the School Board if they change the major revenue sections of the budget or if they change any expenditure functions.

The attached budget amendment makes the following change in the school district's budget:

- Transfer \$70,000 from Function 81 (Capital Outlay) to Function 11 (Instruction) to fund the cost of equipment and supplies for the Cosmetology & Welding program for Career & Technology allotment
- Transfer \$40,000 from Function 11 (Instruction) to Function 23 (Principal Leadership) for cost of salary and travel expenses
- Transfer \$ 2,000 from Function 11 (Instruction) to Function 21 (Special Ed Leadership) for cost of travel expenses
