### STORMWATER DRAINAGE AND DETENTION EASEMENT AGREEMENT

#### **GRANT OF EASEMENT**

DENTON INDEPENDENT SCHOOL DISTRICT (hereinafter called "The District"), for and in consideration of the sum of TEN DOLLARS, (\$10.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby grant and convey unto CITY OF DENTON of Denton, Texas, and to its respective successors and assigns, a perpetual easement for the operation of a storm water drainage and detention facilities easement (hereinafter referred to as the "Easement") in, across, under, over and through the tract of land (hereinafter sometimes referred to as the "Easement Tract") situated in Denton County, Texas, described in Exhibit "A" and depicted in Exhibit "B", both attached hereto and made apart hereof for all purposes.

## **PURPOSE OF EASEMENT**

The Easement, rights, and privileges herein granted shall be used only for the purposes of constructing, maintaining, and operating storm water drainage and detention facilities.

CITY OF DENTON shall have the reasonable right of ingress and egress over and across the Easement Tract and the reasonable right from time to time to remove any obstructions that may injure the storm water drainage and detention facilities or interfere with the construction, maintenance, inspection, operation, or repair thereof.

The grant of the Easement is expressly made subject to the purposes stated herein and to any and all easements, restrictions, reservations, conditions or other matters or record in the Office of the County Clerk of Denton County, Texas affecting the Easement Tract.

#### **DURATION OF EASEMENT**

TO HAVE AND TO HOLD said Easement unto CITY OF DENTON for the purposes mentioned above, until the storm water drainage and detention facilities are constructed hereunder and so long thereafter as said storm water drainage and detention facilities are located and operated thereon, and the District hereby binds itself, its successors and assigns, to warrant and forever defend said premises unto CITY OF DENTON against every person whomsoever claiming or to claim the same or any part hereof, subject to the terms herein, by, through, or under The District but not otherwise

#### **ENCROACHMENTS**

By acceptance of this grant and utilization of any rights granted hereby, CITY OF DENTON agrees that it will at all times, after doing any work pursuant to the rights hereby granted, restore the surface of the Easement Tract to the same conditions in which same was found before such work was undertaken; that it shall construct, operate and maintain such storm water drainage and detention facilities within the Easement Tract so that such facilities will not create a nuisance, and that CITY OF DENTON will not do any act, or fail to do any act, that will be detrimental or create a hazard to the surface of the lands covered thereby or to the use thereof.

#### RIGHTS RESERVED

The Easement herein granted is a non-exclusive easement and the District and its successors and assigns shall have the right to use and enjoy the Easement Tract for all purposes which do not unreasonably interfere with the use thereof by CITY OF DENTON for the purposes for which said Easement is granted.

## **TERMINATION**

The easement, rights, and privileges granted hereunder shall terminate when, or at such time, that the terms provided herein are violated, the purposes hereof cease to exist or are abandoned by CITY OF DENTON, or the purposes herein become impossible of performance.
