In this Cover Letter, there is a base project & three different alternative proposals. We have named each project the following:

- Base Project
- Alternative 1 Project
- Alternative 2 Project
- Alternative 3 Project

We have structured our proposal this way to make sure the district has an apples-to-apples comparison to all other bidders who submit their project based on the Wheaton Engineering drawings dated August 22<sup>nd</sup>, 2024. However, after walking the facility with our own E3 personnel and potential subcontractors, there were items that E3 deems necessary and critically important to include in the project for the long-term success of the facility's HVAC system.

Please find directly below a summary of these options. The detailed Scope of Work for each Option below will follow this summary section and be named as follows:

- SCHEDULE A BASE PROJECT SCOPE OF WORK
- SCHEDULE A ALTERNATIVE 1 PROJECT SCOPE OF WORK
- SCHEDULE A ALTERNATIVE 2 PROJECT SCOPE OF WORK
- SCHEDULE A ALTERNATIVE 3 PROJECT SCOPE OF WORK

#### **SCOPE OF WORK SUMMARIES**

E3's BASE PROJECT CONTRACT - \$4,152,239 + Service Contract with TRANE for \$182,594

REVISED - E3's BASE PROJECT CONTRACT - \$3,711,577 + Service Contract with TRANE for \$178,594

It is our intention to provide the district with a proposal based on what is currently engineered by Wheaton Engineering. We will call this project the BASE PROJECT. However, Wheaton Engineering also asked for a 5-Year Service Contract as part of the BASE PROJECT. We have negotiated a price with TRANE for a service contract on behalf of EPISD, but the service contract will be a direct contract with Trane. This will save the District money contracting directly with TRANE for this service contract.

\*One important item that E3 has included in our base project that may be different from other proposals is regarding the ceiling tile work. In the areas where ductwork is being replaced with new ductwork, the ceiling tile will need to be removed and replaced with other existing ceiling tiles. It has been our experience that the finished ceiling tile looks like patchwork when completed this way. Because of this, E3 has included new ceilings in the classroom wing corridors where tile is being removed due to the work performed in our Base Project.

## ALTERNATE 1 PROJECT - \$481,852 ADD TO BASE PROJECT REVISED - ALTERNATE 1 PROJECT - \$444,286 ADD TO BASE PROJECT

The classroom low-pressure ductwork was not removed and was re-used in the Base Project. This alternate removes the classroom low-pressure ductwork and replaces it with new metal ductwork installed and sized according to what is shown in the engineering drawings provided by Wheaton Engineering. Ceiling tile replacement in the affected classrooms is also included in this alternate.

#### ALTERNATE 2 PROJECT - \$754,656 ADD TO BASE PROJECT

#### REVISED - ALTERNATE 2 PROJECT - \$663,869 ADD TO BASE PROJECT

Only one (1) chiller (CH-1) was replaced in the Base Project. This alternate removes the remaining two (2) chillers (CH-2 & CH-3) and replaces them with identical machines matching the specifications of the new Base Project replacement chiller.

#### ALTERNATE 3 PROJECT - \$228,581 ADD TO BASE PROJECT

#### REVISED - ALTERNATE 3 PROJECT - \$194,506 ADD TO BASE PROJECT

The existing secondary pump room equipment is being re-used in the Base Project. E3 recommends the existing hydronic equipment and piping in the secondary pump room be replaced. This alternate replaces the two (2) secondary chilled water pumps, expansion tank, air separator, pump room hydronic piping, pump inertia bases, suction diffusers, multi-purpose valves, and flex connectors. This alternate also provides for the installation of new variable frequency drives for the two (2) secondary pumps.

#### TOTAL REVISED PROJECT COST FOR THE BASE PROJECT AND ALTERNATIVE 1 2 & 3 PROJECTS IS: \$5:014:238

#### TOTAL REVISED PROJECT COST FOR THE TRANE SERVICE CONTRACT IS: \$178,594.

Due to the uncertainty of the AHU lead-times, E3 cannot guarantee the AHU will arrive in Eagle Pass ISD in time for a summer installation. However, this is the goal.
