

### RIVER ROAD I.S.D. 2013-2014 BUDGET ASSUMPTIONS

- 1. ADA for 2013-2014 will be 1,340.
- 2. The Legislature will appropriate an additional \$3.2 billion for schools.
- 3. Teachers will receive a \$2,000 salary increase.
- 4. Other staff will receive a 4.8% pay increase.
- 5. Salaries will not be approved by the Board until the legislature passes the State Budget.
- 6. The District will hold a Tax Ratification Election (TRE) to increase M&O Fund revenues.













- Salary increases to become competitive (75%)
- Infrastructure needs
