


I have spent most of my life teaching children in ceramics and other areas as well. It is my love for children that leads me to give them to an organization that will continue to do this work.

I have found that by teaching children a love of art, we will give them something with which they can occupy their time and efforts.



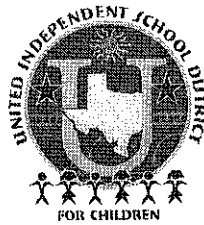
