A-1 2020 Open-Enrollment Charter School Application Approval Request.

Director of Public Charter Schools Tracy Webb presented the Panel with a request for approval of the updated 2020 Open-Enrollment Charter School Application.

A question and answer period followed.

Ms. Newton moved, seconded by Dr. Williams, to approve the revised Open-Enrollment Charter School Application. Motion carried unanimously.

A-2 2020 District Conversion Charter School Application Approval Request.

Director of Public Charter Schools Tracy Webb presented the Panel with a request for approval of the updated 2020 District Conversation Charter School Application.

A question and answer period followed.

Dr. Kremers moved, seconded by Ms. Newton, to approve the District Conversion Charter School Application. Motion carried unanimously.

A-3 Request for Open-Enrollment Charter School Amendment: Haas Hall Academy, Bentonville

Staff Attorney Mary Claire Hyatt advised the Panel that Haas Hall Academy asked that their amendment request be pulled from the agenda.

A-4 Request for District Conversion Public Charter School Charter Amendment: Hot Springs Junior Academy, Hot Springs

Charter Schools Office Program Advisor Kelly McLaughlin introduced the Hot Springs Junior Academy team and provided the audience with instructions pertinent to the proceedings.

Assistant Superintendent Taryn Echols, of the Hot Springs Junior Academy presented an overview of the request for a charter amendment for a relocation of the existing campus, a change in grade levels served from grades 7-8 to grades 7-9 and a waiver to pair oral communication with civics.

A question and answer period followed. The waiver to pair oral communication and civics was rescinded.

Dr. Williams moved, seconded by Mr. Rogers, to approve the charter application renewal request pertaining to the relocation and reconfiguration. Motion carried unanimously.

A-5 Request for District Conversion Public Charter School Charter Amendment: Hot Springs World Class High School, Hot Springs

Assistant Superintendent Taryn Echols, of Hot Springs World Class High School presented an overview of the request for a charter amendment for a grade level reconfiguration from grades 9-12 to grades 10-12.

A question and answer period followed.

Mr. Rogers moved, seconded by Dr. Kremers, to approve the charter application amendment request. Motion carried unanimously.

A question and answer period followed pertaining to Hot Springs Junior Academy.

Dr. Kremers moved, seconded by Ms. Newton, to approve the Hot Springs Junior Academy amendment request for an enrollment cap increase from 600 to 800. Motion carried unanimously.

Chair Pfeffer requested the Charter Schools Office to prepare an overview report for District Conversion Charter Schools as a platform of discussions for future meetings.
