SUBJECT: Sidewalk Tractor Bid

MOTION: That the Board of Education of Oak Park District 97 award a three-year lease-to-purchase contract to Standard Equipment for a sidewalk tractor in the annual amount of \$39,193.40 as outlined in the memorandum to the Superintendent dated April 24, 2012.

SUBJECT: Sidewalk Tractor Bid

DATE: April 24, 2012

Included in the 2011-12 Operations & Maintenance Fund budget was a line item to purchase a piece of snow removal equipment, specifically \$30,000, for a sidewalk tractor. However, after the school year commenced, and we were ready to go out to bid, we learned that this piece of equipment was far more expensive than the original quote provided. The original quote's low estimate was due to the fact that it was a floor model. Recognizing that we did not have sufficient monies in the O & M Fund, we decided to wait one more year to bid.

The actual piece of equipment runs well over \$100,000 but it can be bid as a *"lease to purchase option"*, thus stabilizing the annual allocation for this purchase within the O&M Fund. The low bidder offered \$113,984 and the second bidder offered \$115,399.

Attached is the legal notice, published in the *Oak Leaves* on March 29, 2012, along with the list of vendors invited to bid and the bid summary. We are recommending award of this "lease to purchase" option to Standard Equipment, over the next 3 years (\$39,193.40) or \$117,580.20, commencing with the 2012-13 school year.

The additional cost annually will be offset by a reduction in overtime (currently 2 to 3 men need to be called in per school for snow removal which typically takes between 2-3 hours). With this sidewalk tractor, an entire building can be addressed within a ½ hour. Secondly, work can be completed sooner because the level of noise of this tractor is significantly quieter than the snow blowers. Thirdly, because this tractor also has a brush, the area at Julian, which recently had pavers installed, can be brushed rather than plowed, again saving manpower and wear and tear on the surface. Finally, the Director of Buildings & Grounds indicates this tractor can be used for other purposes, like a bobcat for the removal/hauling dirt, equipment, etc. The life of this piece of equipment is estimated at 20 years.

It is intended to bring this item back for formal Board approval at its May 8, 2012 meeting.
