BOARD OF MANAGERS RESOLUTION SEPTEMBER 7, 2018

A RESOLUTION RELATING TO DESIGNATION OF INVESTMENT OFFICERS

WHEREAS, the Nueces County Hospital District (the "Hospital District" or "District") is a political subdivision of the State of Texas, established and created pursuant to the Texas Constitution, Article IX, Section 4 and the Texas Health and Safety Code, (the "Health Code") Chapter 281, and operated in accordance with the Health Code and other applicable laws of the State of Texas, including the Texas Government Code, Public Funds Investment Act, Chapter 2256 (the "Public Funds Investment Act");

WHEREAS, the Hospital District's Board of Managers (the "Board") is the District's governing board, pursuant to collective authorities of Health Code, §281.021, §281.047, and §281.048;

WHEREAS, the Board, has previously adopted an Investment Policy (the "Investment Policy") pursuant to the Public Funds Investment Act, Texas Government Code, §2256.005(a) and the Hospital District is required by said Act, §2256.005(f) to designate one or more officers or employees as investment officer(s) to be responsible for investment of the Hospital District's funds consistent with the Investment Policy; and

WHEREAS, the Board desires to amend its designation of officers or employees as the Hospital District's investment officers due to the departure an employee who previously served as a secondary investment officer.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MANAGERS OF THE NUECES COUNTY HOSPITAL DISTRICT, THAT:

- 1. The Board hereby confirms **Mr. Jonny Hipp**, the Hospital District's Administrator, as the primary investment officer and **Ms. Donna Littlefield**, the District's Director of Accounting/Finance as an additional secondary investment officer as said investment officers are distinguished by Section III.E. of the Investment Policy.
- 2. The Board hereby designates **Ms. Belinda Chism**, the District's Assistant Administrator, as a secondary investment officer as said investment officer is distinguished by Section III.E. of the Investment Policy.

- 3. The Board's prior designation of **Ms. Dena Bruni** as a secondary investment officer is hereby revoked and the Hospital District's Administrator is hereby authorized and directed to provide written notification of such revocation to the appropriate entities.
- 4. The Administrator, in his capacity as the Secretary of the Hospital District Board, be and is hereby legally authorized and empowered to perform all acts described above and certify these resolutions and that the provisions hereof are in conformance with the laws of the State of Texas and the Governing Board Bylaws of the District.
- 5. This Resolution shall take effect and be in full force and effect upon and after its passage.
