## **Recess into Closed Meeting**

**Board President:** The Board of Trustees may conduct a closed or executive meeting or session under the Texas Open Meetings act, Government Code, Chapter 551, Subchapters D and E. Before any closed meeting is convened, the presiding officer will publicly identify the section or sections of the Act authorizing the closed meeting. All final votes, actions, or decisions will be taken in an open meeting.
