

# Morrow County School District

## Healthy and Safe Schools Plan

1. **Matt Combe, Maintenance Director is responsible for maintaining and updating the Healthy and Safe Schools Plan.**
2. **This plan covers the following District facilities:**

  - Heppner J/Sr High School, 710 NW Morgan Street, Heppner, OR 97836
  - AC Houghton Elementary School, 1105 N. Main Avenue, Irrigon, OR 97844
  - Irrigon Elementary School, 490 SE Wyoming, Irrigon, OR 97844
  - Irrigon Jr/Sr High School, 315 E Wyoming, Irrigon, OR 97844
  - Morrow Education Center, 240 Columbia Lane, Irrigon, OR 97844
  - District Office, 240 Columbia Lane, Irrigon, OR 97844
3. **Morrow County School District has adopted a radon plan as required by ORS 332.167. A copy of the radon plan as well as test results will be made public and posted to the district website at [www.morrow.k12.or.us](http://www.morrow.k12.or.us) under Facilities.**
  - a. This plan will include testing for radon in any frequently occupied room in contact with the ground or located above a basement or a crawlspace once every 5 years.
  - b. Radon test results will be provided to the MCSD School Board, Oregon Health Authority (OHA) and made available on the school district websites. Safe radon levels will be reported in accordance with recommendations from the United States Environmental Protection Agency (EPA).
4. **Morrow County School District's plan for testing for lead in drinking will include:**
  - a. **Identify sources of lead:** MCSD will test all school taps used for drinking or food preparation in all buildings to identify any lead problems and will follow the Environmental Protection Agency's 3 T's Revised Technical Guidance to ensure that samples for lead are collected properly and from the right places. MCSD will use an OHA-accredited drinking water laboratory to analyze samples for lead.
  - b. **Stop access:** MCSD will prevent access to water taps that have more than 20 parts per billion (PPB) of lead. This will include shutting off taps, covering water fountains, and providing bottled water to students and staff members.
  - c. **Communicate:** MCSD will make results from tests for lead in water available to students, families, and the community within 5 business days of receiving results.
  - d. **Mitigate and correct:** MCSD will replace the sources of lead in building plumbing. Again, EPA 3 T's Guidance should be followed.
  - e. Testing was completed in June of 2016 and will be done every 5 years or on an as needed basis. All testing will be in compliance with State and Oregon Health Authority guidelines.

5. **In order to comply with the United States Environmental Protection Agency's Renovation, Repair and Painting Program Rule, MCSD will follow this plan for reducing exposure to lead paint.**
- EPA's 2008 Lead-Based Paint Renovation, Repair and Painting (RRP) Rule (as amended in 2010 and 2011), aims to protect the public from lead-based paint hazards associated with renovation, repair and painting activities. These activities can create hazardous lead dust when surfaces with lead paint, even from many decades ago, are disturbed. The rule requires workers to be certified and trained in the use of lead-safe work practices, and requires renovation, repair, and painting firms to be EPA-certified. These requirements became fully effective April 22, 2010.
  - Painting firms hired to do painting in schools will be EPA certified in order to remain in compliance with EPA's Lead-Based Paint Renovation, Repair, and Painting Rule.
6. **Morrow County School District has adopted an Integrated Pest Management Plan (IPM) as required by ORS 634.700 through 634.750. A complete copy of the IPM Plan can be viewed by visiting the district website at [www.morrow.k12.or.us](http://www.morrow.k12.or.us) and clicking on the Facilities tab. Integrated Pest Management Plan.**
- MCSD has adopted an integrated pest management plan for use on all campuses in the district. The IPMP includes provisions for:
- Designation of the integrated pest management plan coordinator;
  - Plan coordinator responsibilities;
  - Giving notices under ORS 634.740;
  - Retaining pesticide application records under ORS 634.750.
  - Providing a process for responding to inquiries and complaints about noncompliance with the integrated pest management plan;
  - Conducting outreach to the school communities about the school's integrated pest management plan.
  - The integrated pest management plan will be kept on file in the District Office.
7. **Healthy and Safe Schools Plan for reporting results.**
- Test results will be made public within five business days of receiving results.
  - Results will be made available to the public by posting results on the district website, sending notice over the email systems and making results available in hard copy at the main administration office.
  - MCSD will provide detailed information explaining the results.
8. **The District will provide public annual notice regarding Healthy and Safe Schools Plan.**
- Notice will go to all building occupants, parents, and community. Information will be available on the District website and available in the main administration office. The annual statement will contain the following:
