The meeting was called to order by Board President Rick McDaniel.

President McDaniel asked for the roll to be called. The Board Secretary called the roll. Also, present Superintendent Dan Frazier, Student Representative Kaitlin Alfaro, and Board Secretary Thelma Martinez. President McDaniel determined that a quorum was present.

President McDaniel asked the board to approve the agenda. Moved by Schlichting, seconded by Berkland. Motion carried 6/0.

School Improvement: Elementary Fall Fast Testing

Second grade teacher Christine Schultz and Mari Henrichs explained to the board the online tools they used to reinforce the lessons. They also, presented the data for the Fast Testing.

Superintendent Frazier welcomed Student Representative Kaitlin Alfaro. Superintendent Frazier mentioned the greenhouse change orders; he also, mentioned the excellent bus inspection. Superintendent Frazier commented on the upgrade for the classrooms video and sound systems. Dr. Frazier presented to the board the Unspent Balance Report for Fiscal Year 2020. Finally, Superintendent Frazier explained to the board the CARES money the district has received and how is been expend.

Principal Young mentioned Buddy's Pantry is the Belmond-Klemme food pantry located at Jacobson, the pantry is operated by school staff and volunteers and it's open to all students and their families in the Belmond-Klemme District. Mr. Young also mentioned that the meals waivers have been extended for the entire 2020-2021 school year.

Principal Fisher mentioned the Professional Development day with teachers, he also, mentioned that this year the teacher-parent conference will be hold online. Mr. Fisher mentioned the upcoming activities.

Plans for Phase III of the High School Renovation Project and Architect Contract Architect Wineinger presented to the board the design and schedule for the phase III of the high school renovation via zoom. Excess Cost of Limited English Proficient Program

Ms. Greenfield explained the fiscal year 2020 LEP Allowable Cost. Superintendent Frazier recommended the board move to approve the SBRC application for a modified supplemental amount to cover our excess cost of \$126,818.84 for providing our LEP program for Fiscal Year 2020.
