and district leaders.

Plan addressed: Our plans are to continue our Texas Instructional Leadership

work with the Region 4 Education Service Center. It is building the capacity of our instructional leaders to implement practices that improve the observation and feedback cycles with teachers and campus leaders in a way that they are mindfully planning responses to student and teacher data after major assessments. The work benefits district & campus leaders, teachers & students.

Background: The 2024-2025 Instructional Leadership Grant Opportunity was

one of many grant opportunities TEA offered under LASO 3. LASO stands for Learning Acceleration Support Opportunities. It

is a type of Title I, Part A, Section 1003 grant. TEA listed

Landrum, Spring Forest and Northbrook Middle schools as well as Woodview Elementary as eligible to apply based on their federal accountability 2024 ratings indicating comprehensive or

targeted support was needed.

Impact of this action: If the grant award is approved, SBISD will implement the plan. If

the award is not approved, SBISD will evaluate funding options. If SBISD executes this grant well in the 2025-2026 school year, it will be eligible to apply for a second year of funding at a reduced amount of approximately \$50,000 for the 2026-2027 school year.

Budget information: SBISD will use contract with Region IV Educational Service

Center for professional development services. Funds must be

expended by September 30, 2026.

Title: Burns & McDonnell STEM Grant

Administration It is recommended that the Board of Trustees approve the Recommendation: acceptance of this grant award for Spring Woods High School

(SWHS) from The Burns & McDonnell Foundation for \$5,000.

Authority for this action: Policy CDC (Local) states that any gift with a cost or market

value of \$5,000 or more, any gift that the potential donor has expressly made conditional upon the District's use for a specified purpose, or any gift of real property, shall require Board

approval.

Plan addressed: The purpose of this grant is to gain resources for SWHS

Chemistry Students to use in class and for National Honor Society to use as outreach to its local middle and elementary schools. The number of students reached at SWHS would be around 400 students and with outreach, another 300 students.

Background: Texas has implemented new science standards, and we need

materials to help engage our students in thinking about the world around them and the science behind it. A SWHS chemistry teacher wrote, budgeted and submitted the grant proposal awarded to SWHS. It was funded partially due to SWHS's large population of economically disadvantaged students and its commitment to outreach in feeder middle and elementary

schools.

Impact of this action: If the grant award is approved, SBISD will implement the plan.

If the grant award is not approved, the Principal of Spring Woods

High School will evaluate funding options.

Budget information: The Burns & McDonnell Foundation will directly issue a check to

Spring Woods High School to purchase STEM supplies.

Monitoring and reporting

timeline:

The Principal for Spring Woods High School will approve the supplies purchased by the chemistry teacher who submitted the

grant application. The Director for Grants will assist the chemistry teacher as needed in submitting the narrative and financial progress reports requested by the Burns & McDonnell

Foundation, up to two times in the 2025-26 academic year.

United Way Bright Beginnings Initiative

Administration Recommendation:

It is recommended that the Board of Trustees accept training, education, goods, and services valued at approximately \$50,000 for the 2025-2026 school year - approximately \$10,000 for each of the following: Bear Boulevard Child Care, Lion Lane Child Care, Child Development Lab School at Tiger Trail, Wildcat Way Child Care and Zebra Zone Child Care.

Authority for this action:

Policy CDC (Local) states that any gift with a cost or market value of \$5,000 or more, any gift (e.g. grant) that the potential donor has expressly made conditional upon the District's use for a specified purpose ... shall require Board approval."

Plan addressed:

United Way's Bright Beginnings Initiative focuses on transforming child care centers from providing day care to providing the highest quality child development programs through intensive staff development. Program components include:

- 1. Leadership development for center directors
- 2. Intensive staff training
- 3. On-site consultations
- 4. Opportunities to earn supplemental pay upon meeting the Bright Beginnings requirements
- 5. Indoor/outdoor equipment
- 6. Family engagement

The beneficiary of these goods and services will be children, staff and parents at the four Child Care Centers.

Background:

Founded by ExxonMobil and United Way in 2002, the Initiative is an early education program designed so that children achieve developmental milestones through better quality childcare.

Impact of this action

If participation in this grant award is approved, activities will be implemented as planned. This is a continuation of activities previously approved by the Board of Trustees annually since June 27, 2011, with the exception of Zebra Zone Child Care, which was added in 2024. If the grant award is not approved, SBISD will evaluate other funding options.

Budget information

The Director for Grants monitors the budget for all PK Centers. The principals of the PK Centers are the budget approvers for the salary incentive payments, which SBISD distributes quarterly.

Monitoring and reporting timeline:

Each Child Care Assistant Manager serves as SBISD's primary liaison to the program. They will continue to be responsible for all programmatic reporting relative to this funding.
