Important Filing Dates for May 2025 Ballot Measures

February 17th: Last day for a member district to notify the **Tax Supervising and Conservation Commission (TSCC)** if a tax measure is planned for the May 2025 ballot

February 28th: Last day for a local district to file an **SEL 805** notice of

REMINDER FOR SPECIAL DISTRICT CANDIDATE ELECTION

Return District Update Information Form by Jan. 22

Local districts (except our PUDs) have candidate elections scheduled for May 2025, and Multnomah County Elections needs you to confirm which of your district's positions will be on the ballot. Districts are required to do this by returning the District Update Information Form, which was emailed to district contacts in mid-December.

If you haven't already, please return your signed District Update Information Form, with any updates to your board positions, to Multnomah County Elections by January 22nd. Reply to this email if you need a new copy of your district's form sent to you.

February 8th: Filing window opens for district candidates
