## **CONSIDERATION TO APPROVE RESOLUTION #2023-R14 CMAR PROJECTS**

Chief of Operations, Ted Lasiewicz shared the committee of 5 individuals evaluated and scored the 3 contractors that submitted their proposals. Jaynes Corporation received a rating of 95.20, FCI Constructors of New Mexico received 87.67 and Bradbury Stamm, Inc. received 86.60. The CMAR fee to be paid for all three projects is 3.75% of the total MACC (Maximum Allowable Construction Cost) of \$91,472,499 is \$3,430,218.71. General Conditions for these three projects is \$4,972,795 for a total CMAR Fee of \$8,403,012.71. The pre-construction fee for all three projects has been negotiated to be \$599,970.00. The breakdown of that amount for each project is as follows:

Farmington Preschool Academy East 26.57% = \$159,412.03

Heights Middle School 45.54% = \$273,226.34

Mesa Verde Elementary School 27.89% = \$167,331.63

Mr. Corley noted that the Finance Committee had met and he recommended that the Board approve the Resolution for Jaynes Corporation as the CMAR projects.

Superintendent Diehl recommended the Board approve the Resolution #2023-R14 CMAR Projects as presented.

It was moved by Andra Stradling, seconded by Barbara Tedrow to approve RFP 2023-07 as presented. The motion carried with the following vote – Ayes: Joan Vallee, Barbara Tedrow, Keith Corley and Andra Stradling. Nays: None. Motion carried.
