#### D. REPORTS

### 1. Financial Report

a) Budget 2019-20

Mrs. Rexroad presented the 2019-20 tentative budget. Mrs. Rexroad stated that total expenditures are down \$1,051,693.00 primarily due to allocation of IDEA funds directly to districts beginning in the 2019-20 fiscal year. Although 2019-20 IDEA grants will no longer flow through District 843, the Cooperative still has budgeted some IDEA Flow-Through revenue and expenditures in order to close out the 2018-19 grants. Mrs. Rexroad discussed the actual operating expenditures, Base Fund Minimum (BFM), and a proposal summary for hourly wage increases over the next five years, from the handout provided. The proposal addresses current minimum wage requirements.

# 2. Director's Report

a) Summary of Governing Board Action

Mrs. Rexroad shared that the following items were approved by the Governing Board

- Audiological Services agreement with KASEC for 2019-20.
- The loan repayment from July 2018 in the amount of \$500,000.00 from the Transportation Fund to the Education Fund, and approved a new loan of \$250,000.00 from the Education Fund to the Transportation Fund.
- The Treasurer's Bond in the amount of \$1,750,000.
- BMO Harris Bank as Depositories of Funds for 2019-20.
- The purchase of SDS web-based financial software package.
- 12 month support staff increases.
- Collective Bargaining Agreement for 2019-24 with LWASEA.
- The purchase of office furniture.
- The Director's Goals for 2019-20.

- The 2019-20 school calendar.
- Not to open to the public Closed Minutes.
- The Destruction of audio recordings of Closed Minutes.

### b) ESY

Mrs. Rexroad stated that ESY had a slight shift in numbers from projected amounts. Eleven students at Grand Prairie and two students at Pioneer Grove did not attend. Mrs. Rexroad will give the information of the students who did not attend to the Directors of Special Ed.
