Pursuant to Section 4.02.4 of the Arkansas Department of Education Rules Governing Public Charter Schools, we are submitting a Charter Amendment Request Form with additional documentation pertaining to the request. The purpose of this submission is to request the following amendment to the AMS Schools – Arkansas charter:

- 1. Add a new K-8 campus in Fort Smith, Arkansas to open in the Fall of 2026 as AMS Fort Smith.
- 2. Add a new K-8 campus in Jonesboro, Arkansas to open in the Fall of 2027 as AMS Jonesboro.
- 3. To increase AMS Schools Arkansas' enrollment cap to 2,010 to account for:
  - AMS Fort Smith serving up to 810 students beginning in the Fall of 2026.
  - AMS Jonesboro serving up to 600 students beginning in the Fall of 2027.
- 4. To maintain all current waivers held by AMS Little Rock for both new campuses.

We ask that this amendment request be placed on the March 20, 2025 meeting agenda of the Charter Authorizing Panel for consideration.



# V. Map of present location



Potential Location #1: 2121 Towson Ave, Fort Smith, AR 72901



# VI. Map of proposed locations – AMS Fort Smith (cont.)


Potential Location #2: 6600 S Hwy 71, Fort Smith, AR 72908





#### VII. Map of proposed location – AMS Jonesboro\*

AMS Schools – Arkansas is currently in the initial stages of facility identification in Jonesboro. In alignment with our mission, vision, and values, we will pursue a viable school facility and/or land in Jonesboro to serve economically disadvantaged students who otherwise attend schools with poor academic performance. The focal point of this search will be in the areas of Jonesboro with the highest density of families with a Household Income (HHI) below \$50k (circled below). The circled area below contains 16 C, D, and F-rated schools serving a high FRL student population. Jonesboro also does not have any charter schools with further exacerbates the need for an AMS K-8.

#### VIII. Desegregation Analysis

#### I. <u>Introduction</u>

AMS Schools-Arkansas (AMS) is seeking an amendment to open two (2) new campuses within the boundaries of the Fort Smith and Jonesboro School Districts. The Fort Smith campus will house Grade Levels K-8 with a maximum enrollment of 810 students. The Jonesboro campus will house Grade Levels K-8 with a maximum student enrolment of 600 students. The Fort Smith campus, as an open-enrollment public charter school campus unconfined by district boundaries, expects to obtain most of its students from within the boundaries of the Fort Smith (FSSD), Alma (ASD), Charleston (CSD), Greenwood (GSD), Lavaca (LSD) and Van Buren (VBSD) School Districts. The Jonesboro campus, as an openenrollment public charter school campus unconfined by district boundaries, expects to obtain most of its students from within the boundaries of the Jonesboro (JSD), Brookland (BSD), Greene County Tech (GCTSD), Nettleton (NSD), Valley View (VVSD) and Westside (WSD) School Districts. This analysis is provided to inform the decision making of the charter authorizer regarding the effect, if any, that the opening of new charter school campuses in Jonesboro and Fort Smith would have on the efforts of the JSD, BSD, GCTSD, NSD, VVSD, WSD, FSSD, ASD, CSD, GSD, LSD and the VBSD to comply with court orders and statutory obligations to create and maintain a unitary system of desegregated public schools.

#### II. General Analysis

AMS, in this analysis, has carefully reviewed the potential impact that the opening of new charter school campuses in Jonesboro and Fort Smith would have upon the efforts of affected school districts to comply with court orders and statutory obligations to create and maintain a unitary system of desegregated public schools. In conducting its review, AMS has found that neither FSSD nor its surrounding school districts listed above (ASD, CSD, GSD, LSD and VBSD) are under any court orders concerning their desegregation obligations, and are unitary in all aspects of their school operations. As to the Jonesboro campus, AMS has found that neither JSD nor its surrounding school districts listed above (BSD, GCTSD, NSD, VVSD and WSD) are under any court orders concerning their desegregation obligations, and are therefore unitary in all respects of their school operations. Therefore, the opening of new AMS charter school campuses in Jonesboro and Fort Smith cannot be said to have a negative impact on the JSD, BSD, GCTSD, NSD, VVSD, WSD, FSSD, ASD, CSD, GSD, LSD and VBSD's ability to comply with their statutory obligations to create and maintain a unitary system of desegregated public schools.

#### III. AMS Student Information

According to enrollment figures provided earlier in this charter amendment request form as of February 3, 2025, the AMS Little Rock campus had a student population of 496 students, of whom 74.2% were Black; 13.7% were Hispanic, and 8.7% were White.

#### IV. Fort Smith Campus Student Information

Concerning the proposed Fort Smith campus, the FSSD had a student population of 13,683 students, of whom 37.4% were Hispanic; 35.7% were White, and 9.8% were Black. The ASD had a student population of 3,052 students, of whom 80.8% were White and 6% were Hispanic. The CSD had a student population of 875 students, of whom 92.5% were White. The GSD had a student population of 3,850 students, of whom 78.8% were White, and 7.9%



were Hispanic. The LSD had a student population of 747 students, of whom 82.8% were White and 5.2% were Hispanic. The VBSD had a student population of 5,603 students, of whom 62.4% were White, and 21.8% were Hispanic. Ark. Code Ann. §6-23-106 also requires that AMS's operation of the charter school campuses will not serve to hamper, delay or in any manner negatively affect the desegregation efforts of a public school district or districts within the state. AMS's careful review of the relevant statutes and orders affecting the JSD, BSD, GCTSD, NSD, VVSD, WSD, FSSD, ASD, CSD, GSD, LSD and VBSD, and the student populations of such districts, shows that such negative effect is not present here.

#### V. <u>Jonesboro Campus Student Information</u>

Concerning the proposed Jonesboro campus, the JSD had a student population of 6,447 students, of whom 47.2% were Black, 31% were White, and 15.6% were Hispanic. The BSD had a student population of 3,063 students, of whom 86.5% were White. The GCTSD had a student population of 3,334 students, of whom 90.4% were White. The NSD had a student population of 3,806 students, of whom 54.9% were Black, 24.6% were White, and 12.3% were Hispanic. The VVSD had a student population of 2,875 students, of whom 81.4% were White, 5.1% were Black, and 5.1% were Hispanic. The WSD had a student population of 1,737 students, of whom 91.4% were White.

#### VI. Conclusion

In conclusion, AMS submits that upon the basis of its review, no statutory or other impediments concerning the creation and operation of desegregated public schools prohibit the State's charter school authorizer from granting its amendment request to open two (2) new AMS open-enrollment public charter school campuses, AMS Fort Smith to open in 2026 and AMS Jonesboro to open in 2027, within the boundaries of the Fort Smith and Jonesboro School Districts.
