Annual Measurement of Achievement (ESEA 1111(c)(4)(E)(iii))

If a school does not meet the 95 percent participation requirement for all students, 95 percent will be used for the denominator for purposes of measuring, calculating, and reporting.

Additionally, in the accountability system, if a school does not meet the 95 percent participation requirement for any subgroup of students, 95 percent will be used as the denominator for each subgroup for the purposes of measuring, calculating and reporting. All calculations will be conducted both for the all students group and for each student group meeting minimum group size requirements (N=15).

For schools that do not meet the 95 percent participation requirement for two consecutive years, the ADE will require each school to submit a plan that includes strategies for meeting participation requirements. For schools that do not meet the participation requirement for multiple years or that do not show sustained improvement in meeting the 95 percent participation rate, the ADE will implement additional actions and interventions as appropriate.
