## **Accepting Road Commission Applications**

The Alpena County Board of Commissioners are now accepting applications for two (2) positions on the Alpena County Road Commission Board. This commission holds their regular meetings on the first Tuesday of each month at 3:00PM at their offices, located at 1400 North Bagley Street. Members usually hold a 6-year term, however, due to the recent vote to expand the membership, these positions will be staggered for their first term and for that reason be considered partial terms. The Road Commission is responsible for the construction and maintenance of county roads and bridges, and the administration of funds allocated from gas and weights taxes. Their mission is to enhance the social and economic quality of life of our community by providing and maintaining, consistent with the financial resources available to the Commission, a safe and efficient system of county roads and streets for the citizens of Alpena County; and to continuously strive to improve the quality of the service they deliver. Commissioners' duties include building relationships in the community, ensuring a fiscally healthy budget, prioritizing projects and future strategic planning, authorizing major purchases, acting on bids and awarding contracts. Those applying to the Road Commission are encouraged to review the handbook for county road commissioners at micountyroads.org/Commissioners-Handbook. Alpena County expects year-round attendance by all road commissioners at all of their meetings.

The individual appointed to the Alpena County Road Commission Board may also be considered for appointment to the Alpena County Parks Commission, by statute, however only one member of the Road Commission will serve on that board at any given time. Please see Alpena County Parks & Recreation Commission for additional responsibilities.
