We need to go narrow with the view to get enough pixels per foot for adequate detail, I just had the camera focused on the wrong area. By moving over and adjusting the same camera and lens proposed we should be able to capture vehicles as they enter the circle drive from W 8th Street or School Drive. I have attached the proposal with an updated drawing reflecting this change. Let me know if this looks better to you.

Hi,

Here's a rough outline of what we're looking for with some high school camera additions:

1. Second floor of high school in the hallway corner of storage room 231. That whole region is a dead zone with existing cameras. Thought was that we should put a camera in that corner to cover the hallway and corridor.

2. First floor of high school in the admin hallway over Mr. Whetsell's door opposite end of the hall of camera HS-04. I think we may need a 180 degree camera then we could cover the outside entrance, stairwell, special ed hallway, and admin hallway all in one camera.

3. Outside the circle drive there are two big concerns. One is that we don't have close up enough coverage of the front doors from the outside.

I have an idea on that one, somewhere outside the principals office possibly putting up another 180 degree camera.

Second issue on the circle drive is that I think we need a camera with tighter focus right on part of the driveway where everyone pulls in. I think we could get a camera with the right lens that would focus up close on the cars pulling in so that we could see who is driving the car and the license plate.

Happy to talk more about this when you have time. If anyone wants to come out on site more than welcome to walk around and show the areas as well. Can reach me at 217-565-3048.
