Date: December 15, 2025

Background:

The adoption of the annual tax levy constitutes a major fiduciary function of the Board of Education. This process is critical as revenues generated from local property taxes account for approximately 84.5% of the School District's total operating revenue. The levy process adheres to the following statutory requirements and internal deadlines:

- Tentative Levy Presentation: The tentative tax levy must be formally
 presented to the Board of Education at least 20 days prior to the date of its
 final adoption.
- Final Adoption Recommendation: The final 2025 tax levy is scheduled to be presented to the Board with a recommendation for formal adoption during the regular meeting on December 15, 2025.
- Filing Requirement: The adopted levy must be officially filed with the County Clerk's Office on or before the last Tuesday in December.

These timelines ensure compliance with state statutes and maintain fiscal transparency within the community.

Situation:

On Thursday, December 4, 2025 a notice was published in the Daily Herald announcing a public hearing to be held at the District Office on December 15, 2025 for the purposes of adopting the 2025 tax levy. Levy amounts were determined based on projected expenditures for the 2025-2026 budget. Revenues from the 2025 levy will be received in June and September, impacting two budget years. The district's levy request reflects an increase of 4.99%.

For your convenience I have attached the four legal documents that will need to be signed by the Board of Education's President and Secretary;

- 1. Resolution Approving the Tax Levy
- 2. Certificate of Tax Levy (ISBE 50-02)
- 3. The Secretary's Certificate for Approving the Resolution of Tax Levy
- 4. Certificate of Compliance with the Truth in Taxation Law

Recommendation:

That the Board of Education of Bloomingdale School District 13, DuPage County, Illinois, approve levies on the equalized assessed valuation of the taxable property of said school district for the year 2025 as described in the Resolution Approving 2025 Tax Levy as presented.

RESOLUTION APPROVING 2025 TAX LEVY

WHEREAS, the Board of Education of Bloomingdale School District No. 13, DuPage County, Illinois, has determined the amount of money that is necessary to be raised by taxation for the year 2025; and

WHEREAS, the Board of Education has heretofore adopted a Budget Resolution for the District for the fiscal year commencing July 1, 2025 and ending June 30, 2026; and

WHEREAS, the Board of Education disclosed at a public meeting its intention to adopt a levy; and

WHEREAS, the Board of Education provided notice of its intent to adopt a levy. NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the Board of Education of Bloomingdale School District No. 13, DuPage County, Illinois, as follows:

- 1. That there shall be and there is hereby levied by the Board the amounts set forth on Exhibit A attached hereto and made a part of this Resolution, which is the Certificate of Tax Levy for the year 2025.
- 2.That the Board President and Board Secretary are hereby authorized to execute the Certificate of Tax Levy and supporting forms and Certifications and the District Administration is hereby authorized and directed to file the Certificate of Tax Levy and all supporting forms and Certifications with the County Clerk of DuPage County, Illinois.
