**RESOLUTION ESTABLISHING POLLING PLACES AND COMBINED POLLING  
PLACES FOR CERTAIN MULTIPLE PRECINCTS AND DESIGNATING VOTING  
HOURS FOR SCHOOL DISTRICT ELECTIONS NOT HELD ON THE DAY OF A  
STATEWIDE ELECTION**

BE IT RESOLVED by the School Board (the "Board") of Independent School District No. 622 (North St. Paul-Maplewood-Oakdale) as follows:

1. Pursuant to Minnesota Statutes, Section 205A.11, the precincts and polling places for School District elections are those precincts or parts of precincts located within the boundaries of the School District which have been established by the cities or towns located in whole or in part within the School District. The Board hereby confirms those precincts and polling places so established by those municipalities.

2. Pursuant to Minnesota Statutes, Section 205A.11, the Board may establish a combined polling place for several precincts for school elections not held on the day of a statewide election.

3. The polling places and combined polling places described in **Exhibit A** to this Resolution are hereby established to serve the precincts specified for all School District special and general elections not held on the same day as a statewide election. The designations herein made shall remain in effect unless any polling place or combined polling place is subsequently changed, in which case the Board must designate, by a resolution adopted by not later than December 31, any changes to such polling places and combined polling places, as provided in Minnesota Statutes, Section 205A.11, subd. 2(b).

4. The Clerk is hereby authorized and directed to designate a new or different polling place in the event that a designated polling place or combined polling has become unavailable for use, or in the event of an emergency in accordance with Minnesota Statutes, Section 204B.175.

5. As required by Minnesota Statutes, Section 204B.16, subdivision 1a, the Clerk is hereby authorized and directed to give written notice of the new location of a polling place or combined polling place to each affected household with at least one registered voter in the School District whose school district polling place location has been changed. The written notice must be a nonforwardable notice mailed at least twenty-five (25) days before the date of the first election to which it will apply. A notice that is returned as undeliverable must be forwarded immediately to the appropriate county auditor, who shall change the registrant's status to "challenged" in the statewide registration system.

6. Pursuant to Minnesota Statutes, Section 205A.09, the polling places and combined polling places will remain open for voting for School District elections not held on the same day as a statewide election between the hours of 7:00 o'clock a.m. and 8:00 o'clock p.m.

7. The Clerk is directed to promptly file a certified copy of this resolution with the County Auditors of Ramsey and Washington Counties.
