Approval of Guaranteed Maximum Price for a Demolition Package for Renovations & Additions to Denton High School as Detailed in the 2007 Bond Referendum

SUMMARY:

- This item requests approval of the "GMP" for an early demolition package for portions of the DHS campus in the amount of **\$165,053.00**.

PREVIOUS BOARD ACTION:

- Board approved 2007 Bond Referendum August 14, 2007.
- Board approved "GMP" for a site utility package submitted by Charter-Heery Builders, Ltd. for \$1,085,458.00 May 27, 2008.

BACKGROUND INFORMATION:

- Summary of Scope:

On the east side of Fulton Street, the scope of work includes the complete demolition and removal of the east field house (Girls sports field house), the eastern half of the west field house (football field house), and the western half of the west field house (work to be completed during the summer of 2009). Also included will be removal of any concrete paving or flatwork required to accommodate the construction of the new field house. On the west side of Fulton Street, the scope of work includes the removal of any concrete paving or flatwork and any remaining structures required to accommodate the construction of the new gymnasium addition.

SIGNIFICANT ISSUES:

- Staff was to seek Board approval of the Guaranteed Maximum Price for all projects detailed in the 2007 Bond Referendum for the Denton High campus July 29th, 2008. However technical difficulties have occurred which have now made this date impossible to accomplish. In order to retain the original construction schedule Staff is seeking Board approval for a demolition package which will allow construction to begin early and maintain the original construction schedule.

FISCAL IMPLICATIONS:

- Costs will be borne by 2007 Bond Funds designated for this project.

- Passage will allow construction to begin immediately so that no time is lost to the original construction schedule
