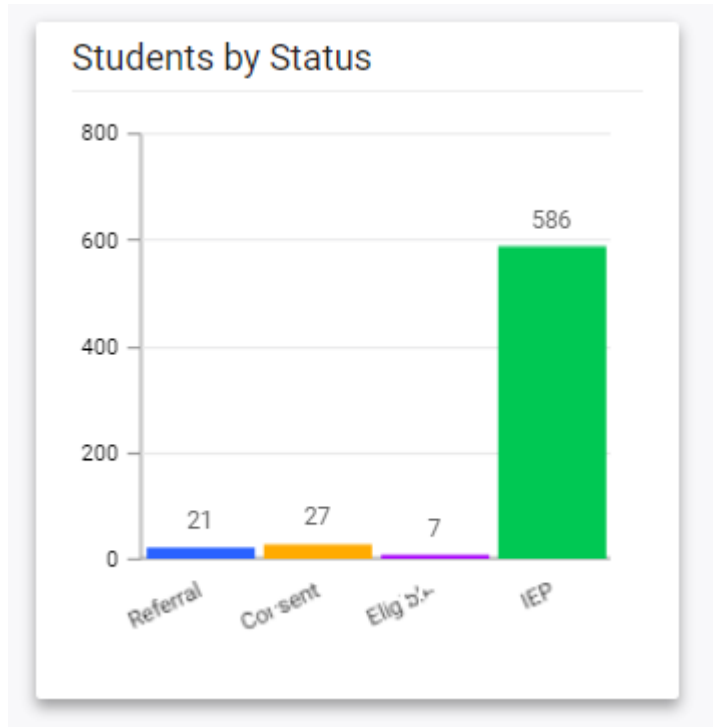
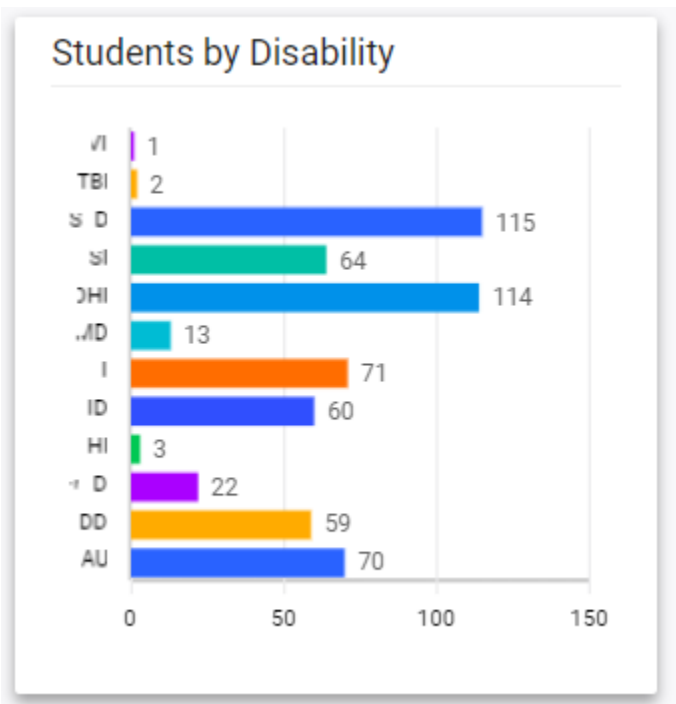


# March Special Education Board Report
