AGENDA ITEM: Consider Approval of Vendor List for Apparel, Awards, Promotional Items, and Spirit Wear

BACKGROUND INFORMATION:

- If it is anticipated the District will spend \$50,000 or more on a class of product during a fiscal year, Aledo ISD policies require the District to purchase those goods or services via a bid or purchasing cooperative.
- Based on historical purchasing patterns, it is anticipated the District will exceed the \$50,000 threshold for the purchase of apparel, awards, promotional items, and spirit wear.
- On April 21, 2023, the District issued Request for Proposal (RFP) 23-042123 through the Aledo ISD eBid System. Electronic responses to this RFP were submitted through the Aledo ISD eBid System until 2:00 PM (CST) on May 8, 2023.
- The original contract period for this bid will be from date of award through May 15, 2024.
- As stipulated in the bid documents, the contract will automatically renew for three (3) one (1) year periods. The District has the option to issue subsequent RFPs as needed.
- Following is the Aledo ISD Apparel, Awards, Promotional Items, and Spirit Wear Vendor List for your review and consideration.

FISCAL INFORMATION:

Purchases made from the vendor list for apparel, awards, promotional items, and spirit wear will be paid with available budgeted funds during the contract period.
