

- Utilized technology dashboards








Illinois Priority Learning Standards

Role of Instructional Technology

- •Essential to ensure high quality remote learning
- •Reliance on uniform platforms (Schoology, Seesaw, Zoom, Powerschool)
- •Incorporates robust tools like Smartboards and Swvil devices
- •Responsive "help desk" resources for support with questions and hardware
- Affords options for both synchronous and asynchronous learning



Special Education - Remote Services

- Direct services provided remotely in alignment with IEP minutes to the greatest extent possible.
- Individual Remote Learning Plans for each student that have been customized and shared with families which align with IEP goals, accommodations and modifications.
- Research based instructional materials that can be implemented remotely (For example: Smarts Executive Functioning, TeachTown, Everyday Speech, etc.)
- Group and Individual tele- therapy
- Co-Teaching Opportunities
- Support from Teaching Assistants in Zoom, general education and special education classes, small group and/or during asynchronous opportunities
- Additional steps taken to streamline communication, assist with executive functioning
- Developing systems for progress monitoring and adjusting how goals might be supported and/or measured.

Special Education - IEP Meetings and Evaluations

- ISBE has provided no timeline exemptions for evaluations and annual reviews
- Teams must be very careful to consider the difference between the impact of school closures and remote learning and what is considered a disability
- School district must adhere to Child Find Obligations
- IEP Meetings are held virtually
- Evaluations some components completed remotely, individualized in person testing when necessary with safety protocols in place.

Special Education - Return to In Person Instruction

Early Childhood Special Education students and students receiving special education services in Multi-Needs classrooms returned to school in person on September 17

Two classes at Willard (EC and Multi-Needs)
Two classes at Roosevelt (Multi Needs)
