- a. StudioGC architecture+interiors Project(s) Update
 - i. Bid for Todd Hall & Lincoln Hall Site Renovations (Todd Hall Courtyard/Lincoln Hall Plaza) Four contractors attended the pre bid meeting, bids are due Thursday, March 2, 2023.
 - ii. Arborist's Analysis

Courtney Whited, Business Manager/CSBO, explained Bartlett Tree Experts' analysis of the two Todd Hall courtyard trees. The Committee recommended replacing them with new trees that have a root system which grows straight down rather than a sprawling, shallow root system.

iii. Rutledge Hall Library Lookbook

The Committee reviewed the plans as presented in the packet.

iv. Pre-Kindergarten and Kindergarten Classroom Furniture

Athi Toufexis, StudioGC, met with Mr. Harmon and the Todd Hall staff to review the presentation and to get feedback. Mr. Harmon commented that the staff really liked rectangle shapes and the kindergarten team was interested in six-foot tables. He also mentioned that most of the staff liked the idea of having the different colored table edges so they can use the coloring to assign students to tables. The staff liked the top handles on the chairs. The Committee decided to hold off on updating the Pre-K cubbies until the Todd Hall millwork refresh in 2026.

- v. Bid for Todd Hall and Rutledge Hall Window Treatments
 One contractor attended the pre-bid visit today. Bids are due Wednesday, March 8, 2023.
- b. Tree of Heaven Struck by Lightning

The Committee recommended consulting with an arborist to evaluate the tree's health caused by two lightning strikes. If this tree poses such a threat to fall or another dangerous situation, the Committee recommended its removal.
