

This is to inform you that I received a letter from the District Superintendent recommending your termination. A copy of that letter setting forth the reasons for the recommendation of termination is attached.

Please be advised that the board intends to address this matter and to act on the recommendation of the Superintendent at a Board Meeting scheduled for the 4^{th} day of October 2016, at 5:00 pm in the District Administration Building.

You have a right to a hearing on this recommendation. You also have a right to waive the hearing; however that waiver must be in writing. Unless we receive a written waiver, we will hold a hearing on this recommendation for termination.

The hearing must be conducted at a regularly scheduled or special meeting of the Board of Trustees. You have the right to present evidence and testimony on your behalf and also have a right to be represented by an attorney, or other individual of your choosing. At the conclusion of the hearing the Trustees will vote to either accept or reject the Superintendent's recommendation for termination.
