These range from bathroom renovations and floor stripping to custodial training and creating SOPs. He keeps up with preventative maintenance and aims to complete projects in house to reduce expensive outsourcing. Examples of these were the shed renovations at Lincoln and Blackstone, lighting, and front entrance at Northbrook.

Russ Rumbold, from Gorenz and Associates, summarized the FY24 audit. He mentioned his team was pleasantly surprised with our District as this is the first year they audit M289. He highlighted key points based on capital projects and we rated a 3.2 out 4. We also received an unmodified opinion, which means that the auditor concludes that the financial statements were reported fairly.
