This letter transmits an update from Plante Moran Cresa (PMC) as it relates to the assignment to assist and advise Livonia Public Schools (LPS) in its selection of Prime Contractors for the Projects listed above. This update represents the mutual efforts of PMC, George W. Auch Co., LPS administration and staff (the Bond Team) to present a framework in order to identify, evaluate and recommend Prime Contractors firms for this Project.

On February 17, 2015 Construction Documents were formally issued and made available. An advertisement for bids was published in a local newspaper and also posted to the required State of Michigan websites.

On March 12, 2015 116 bid proposals were received from 100 separate firms, and over the next several days were reviewed to determine the budget implications. Interviews were held over the next week and were attended by various members of the Bond Team.

Upon completion of the interviews, and after subsequent clarifications and discussions, the Bond Team is recommending the firms listed in George W. Auch Co.'s Award Recommendation Letter dated March 20, 2015 for contract award. Including hard construction, CM fees and costs, and construction contingency dollars, the total Project award recommendation equals \$20,452,073.00.

For the Prime Contractors, the costs for this work will be detailed in AIA Contract A132 – 2009 Standard Form of Agreement between Owner and Contractor. The CM costs and fees will be detailed in Amendment #02 to AIA – C132 – 2009 Standard Form of Agreement between Owner and Construction Manager, both pending final review and approval by district legal counsel.

We have completed the review of the bids received on March 12<sup>th</sup>, 2015 for the Preforming Arts Addition and Renovation project at Franklin High School. The George W. Auch Company is pleased to present the recommendations for award of contracts per the attached schedule. We recommend awarding to the low responsive bidders with complete bid scope.

After post-bid evaluation, we have determined that Pranam Global Tech. does not meet the qualifications to complete the project, as well as, does not self-perform their work to complete the bid categories that they provided a bid. Pranam also made several errors when completing their bid and asked for several bids to be withdrawn. Therefore, we are recommending the low responsive bidder in the Selective Demolition, Storefront / Curtain Walls / Glass & Glazing, and Acoustical Ceilings & Wall Panels categories.
