A) Executive Director's and Enrollment Reports

Preparations for the 24-25 budget revision are in process and will be presented at the February meeting. A CVSEC team is committed to PREPare training thorugh MDE. This is an evidence based training related to school crisis prevention and responses. This will strengthen school safely, crisis management response, and emergency response. Planning and preparations for 25-26 staffing have started.

Enrollment is 100 students. This is the highest number of students enrolled at CVSEC since the Cooperative was formed.

B) <u>Nursing Services</u>

District Nurse Emily Mjelleli spoke to the Board about the complex needs of the CVSEC student population, and gave the Board an overview of nursing services and how they meet those needs. Mjelleli described the varied medical needs of students and the plans that are in place for individual students CVSEC has two licensed school nurses. In addition to daily student care, CVSEC school nurses are also responsible for infection control and

reporting infections to the Department of Health. Additionally, CVSEC nursing staff train and educate other staff members and students on health and safety. Building relationships with families is also important to student wellbeing.
