

Three times a year, District 90 reviews student data to support the MTSS process. Subgroup data is reviewed to determine areas of need. District 90 continues its alignment to the Illinois Learning Standards for reading, mathematics, Next Generation Science Standards, and Social Emotional Learning and maintains the goal that subgroup status or background should not be a predictor of student performance or success on standardized assessments. Review of student data indicates that most stakeholder groups are growing at a similar rate, but the achievement gap still persists in the area of reading and math. Instructional coaches review student assessment data with grade level teams to target skill areas for further development and best practices instruction to support student growth and achievement. The Instructional coaches will work with teachers to target reading and math strategies to close the gap for Title I students.

District 90 conducts data review meetings three ties/year in the Fall, Winter, and Spring through the MTSS process. The District reviews NWEA -MAP, AlmsWeb Plus, Fountas and Pinnell Benchmark Reading Assessment, and math fluency data to surface the range of needs in each classroom. Review of subgroup data allows teachers and grade level teams to utilize small group instruction and/or more personal 1:1 conferring with students within the regular classroom to offer targeted skill/strategy work tightly aligned to student instructional needs. It allow for more tailored instruction and individualized support each student. Title II funding provides professional development that aligns with the Implementation of the Iilinois Learning Standards for reading, math, science, and social emotional learning as well as providing support for trends indicated in the disaggregated data. All professional development is aligned to district goals and objectives as outlined in the District Strategic Plan. D90 continues to target 90% of students will meet or exceed standards on the Illinois Assessment of Readiness in reading and math. We are currently partnering with Responsive Classroom to support teachers with professional learning related to social emotional learning, and the implementation of a new SEL curriculum.
