Summary:	<p>Bellville ISD has solicited proposals for Electrical maintenance services for existing equipment and construction job order contracting for new equipment in one proposal. This proposal will provide competitive pricing on electrical services as well as new equipment.</p> <p>Section 44.031 of the Education Code requires all school district purchasing goods and services, valued at \$50,000 or more in aggregate to competitively procure these services. As Bellville's systems age, more reactive 'emergency' repairs have been taking place and are expected to continue. The nature of these repairs requires access to pre-bid contractors and equipment. The proposal also allows the District to award the RFP to multiple vendors. Multiple vendors would be advantageous for Bellville ISD to have timely access to repair personnel.</p> <p>Bellville ISD received two proposals for RFP #2020-001 with were evaluated according to the criteria as outlined in the RFP.</p>


