8 Board Member Considerations

A. **PEA 3-Year Contract** – It will be the recommendation from the PEA Board negotiating team to approve the 3-year agreement with the PEA.

Action: Motion to approve the 3-year agreement with the PEA.

B. **Review Transition (Back to School) Plan** – We will take some time to review the transition (back to school) plan. Based on the feedback that I received from the transition (back to school) committee, there is agreement that with the number of students who are now attending in person, we should begin attending school 5 days per week in person for the 4th quarter. It should be noted that there are 3-hour early dismissals scheduled for March 17th (parent/teacher conferences), March 24th (SIP Day), and on April 21st (SIP Day). The District will continue to utilize a 2:30 p.m. dismissal for the duration of the 4th quarter, including the Wednesday dates (March 31, April 7, April 14, April 28, May 5, May 12, and May 19) not listed above. Pana CUSD #8 Staff is scheduled to receive the second vaccination on Saturday, March 13th at Pana High School. Due to the side effects that individuals often experience with the second vaccine and the number of employees getting the vaccination, I am recommending that Monday, March 15th be changed to a remote learning day for all students in the event that several staff members become ill.

There is also updated language highlighting remote learning eligibility. Administration also has the authority to require students to return to in-person learning due to a lack of academic progress (i.e. failing grades, lack of participation in remote learning). Additional language clarifies that no student will be allowed to opt into remote learning without a valid medical excuse from a physician which states that the student or an immediate household family member is an at-risk category.

Action: Motion to approve the amended Transition (Back to School) Plan.
