Vicksburg Community Schools received 5 proposals for 1 bid package that was solicited as Series 2 Release 4A, part of the 2020 Bond Projects on December 22, 2022.

B.P. 2.8 Asbestos Abatement – 5 proposals received

Below is our final review, evaluation, and award recommendation.

B.P. 2.8 - High School & Middle School Asbestos Abatement

The Bid Package Work Scope consists of: Abatement/demolition of existing building materials at both the VCS High School and VCS Middle School. The high school abatement project primarily consists of floor tile and floor adhesive removals existing in the 200 and 400 classroom wings. The middle school abatement/demolition project consists of curtain wall removals, glazing removals, and floor tile and adhesive removals in select areas. This project is phased to align with the mechanical, electrical and architectural improvements projects that will be taking place at both schools at the same time. This bid package also has an alternate associated with it. Alternate 1 requests pricing to remove floor tile in 4 additional classrooms at the middle school during the phase II construction schedule.
