**FY17 Preliminary Computer Assisted Budget**

Highlights of summer technology projects are the 135 new flat screen displays purchased for use across the district. All of the older CRT monitors have been sent to recycling. 25 new PC's have been ordered to replace the few remaining Windows XP workstations. The aristotle server has been upgraded and extended to support active content filtering in addition to the passive data collection and web site logging for student chromebooks. The aristotle system is also being added to monitor student workstations throughout the district. Office 2016 licenses have been purchased to upgrade and consolidate the district to one version of office. Dr. Lett explained possible future plans on how the chromebooks will flow from year to year through the 1:1 program. The plan is that as chromebooks become sturdier that we may be able to get 4 years out of the devices for grades 6 through 9. h

6. 1:1 Chromebook Program Review 15-16

Mrs. Miller discussed repair statistics of the chromebooks for the previous school year. The most reported issue was accidental screen breakage. 50 chromebook screens were broken by students and repaired by Mr. Savage last year. Mrs. Miller also discussed survey results relating to the students and teachers experience with the chromebooks. 96% of the students used the chromebooks to write documents, presentations, spreadsheets, and conduct research. More than 90% of the students took quizzes or tests on the chromebooks last year.
