**JOINT AGREEMENT RESOLUTION**

**WHEREAS**, present statutes allow school districts to jointly offer programs for better educational advantages, and

**WHEREAS**, Section 10-22.31a of the School Code of Illinois authorizes joint agreements between several school districts, through their school boards, to establish such programs:

**THEREFORE**, let it be resolved that **PANA COMMUNITY UNIT SCHOOL DISTRICT #8, PANA ILLINOIS**, be authorized to enter into a joint agreement with other school districts of OKAW Area Vocational Center, and be bound thereby, and

**BE IT FURTHER RESOLVED**, that the President and Secretary of the Board are hereby authorized to direct and execute said joint agreement, copy of which is attached hereto, and

**BE IT FURTHER RESOLVED**, that this Board of Education hereby approves of the OKAW Area Vocational Center Programs for the **2023-2024** school year as presented.

In reference to Section 10-22.31a of the School Code, it shall further be noted that school districts participating in the **OKAW Area Vocational Center** cooperative shall not:

1. Duplicate existing programs that are offered at OKAW Area Vocational Center in home district and/or otherwise.
2. Send district students outside the cooperative to programs, which are being offered at OKAW Area Vocational Center.

Districts who desire to discontinue their participation in OKAW Area Vocational Center cooperative must be in constant communication of intent with OKAW Area Vocational Center Director and give written notice of desire to OKAW Area Vocational Center Director one year in advance of withdrawal.

This document is valid and binding with and for all participating parties of said school districts in Joint Agreement Resolution.
