Dear Colleagues:

January is already drawing rapidly to a close! Here are the latest happenings:

1. Caucus Luncheon at the MASA Midwinter Conference

We are looking forward to our next School Equity Caucus General Membership meeting at next week's MASA Midwinter Conference in Detroit! We will be taking a quick look back at last month's lame duck legislative session, and will be looking forward to the prospects for positive change in the upcoming legislature. Additionally, Governor Whitmer will be giving her first State of the State address the night before our meeting, so we will be attempting to read the tea leaves for clues as to where she may head in addressing issues in education.

The luncheon and meeting will be held in the Mackinac Ballroom on the 5th level of the Renaissance Center from 11:15 a.m. to 12:45 p.m. on Wednesday, February 6, 2019 (just prior to the start of the conference).

2. MSU Study Released

It has been about one year since the School Finance Research Collaborative released its adequacy study and recommendations regarding school funding in Michigan. This past week another potentially significant study was released by researchers at Michigan State University.

Entitled "Michigan School Finance at the Crossroads: A Quarter Century of State Control", the report analyzes the state's K-12 school finance system, and provides recommendations for changes to the current funding system (most of which are based on last year's SFRC report).

Among the report's findings are the following:

- Between 1995 and 2015, Michigan ranked 50th in the nation in growth of educational funding. In 2015, funding was only 82% of the amount in 1995 when adjusted for inflation.
- Between 2003 and 2015, Michigan ranked 50th in the nation on student proficiency growth on standardized tests.
- Michigan has seen a "historic drop" in tax effort, along with massive shifts in funding away from the School Aid Fund (to line items previously funded by the General Fund).
- Michigan dramatically underfunds special education causing districts to spend \$500 per general education student to meet requirements. In some districts this number is over \$1200 per general education student. The report calls Michigan's special education funding "unusually stingy".
- Michigan's approach to financing school facilities creates unequal opportunities for students and unequal burdens for taxpayers.
- Funding for at-risk students has fallen by 60% per pupil since the onset of Proposal A.
- Significant problems exist in the state's School of Choice and charter school funding structure.
- In a related report, the authors make a connection between funding and student learning (or lack thereof).

These reports can certainly help provide additional impetus for your conversations with legislators leading up to this year's budget preparation cycle.

3. January CREC Sees Increased Revenues

As reported earlier this month, the latest Consensus Revenue Estimating Conference (CREC) provided some encouraging news, at least in the short term.

Revenue for the budget year concluded last September was up significantly over previous projections. This provided both the School Aid Fund (SAF) and the state's General Fund (GF/GP) with higher starting balances than originally projected.

Looking ahead, the SAF is being projected to grow steadily at 1.6% in 2019, 2.8% in 2020, and 2.4% in 2021 – even on top of this year's higher revenue numbers. Meanwhile, the

General Fund will be much more flat in its revenue growth, according to these projections. This will add additional pressure to an already tight budget, and will make for some difficult choices.

The bottom line is that, if current trends continue, there could possibly be room for increases to the foundation allowance in the upcoming budget, but it is impossible to say how large that increase could be at this time. However, the long-term weakness in the General Fund along with numerous spending pressures could cause trouble.

We will get a better idea of where all this is headed in the Governor's budget, expected out in early March, followed by the proposals from the Republican-controlled legislature.

The next CREC will be held in May and will ultimately form the basis for the numbers to be used in the development of next year's state budget.

4. Other Legislative News

The 100th Michigan Legislature has just begun its work and the many new legislators are beginning to get acclimated. The first bills of this new session are just now being unveiled. Now's the perfect time to make connections with your legislator!
