Presentations/ Recognitions The Denton High Boys Cross Country team finished third at the UIL State Cross Country Meet at Old Settlers Park in Round Rock. It is believed that this is the highest finish posted by a Boys Cross Country Team from Denton High in the school's history. The Broncos finished with a team score of 131 with five runners finishing in the Top 45 of the state's elite runners. The team was also the District 6-5A Runner-Up and the Region 1-5A Runner-Up leading up to their historic finish at State.

Guyer High's Brynn Brown, senior, posted a new course and state record of 16:25.89 in running 5K to win her first UIL Class 6A State Cross Country title at Old Settlers Park in Round Rock in November.

Mark Kiraly, Ryan High School, teaches AP Calculus each day to our local students. He also teaches students across the nation through his affiliation with AP Daily and The College Board. During this time when teaching

students both face-to-face and via ConnectedLearning, Mr. Kiraly has not only mastered his subject area, he stands as an example of how to offer the highest quality of instruction via dual platforms.

Mr. Deaton stated the report showed no errors and recommended no changes to the district's business practices.

He also reviewed the security precautions and reviewed enhancements that the district has implemented regarding student and staff safety. The District received a \$488,000 grant to enhance the safety and security of the District that was received in Spring of 2020. The grant funds will be used for 3M impact resistant film that will be used in campus entryways and additional cameras at middle school campuses. The District has expanded the roll with a safety and security Director, Lt. Mays.

Bond Refunding Program Update

Dr. Scott Niven, CFO provided the Board of Trustees with an update on the bond refunding program. On November 24, 2020, the District sold \$269,445,000 in 2020 refunding bonds with significant savings to the taxpayers. Based on the refunding parameters presented during the October 13, 2020 the district was able to save taxpayers \$67,124,217 in future interest costs without extending the overall life of the bonds. The all-in interest cost dropped from 4.89% to 2.11%.
