The President announced that the next item of business before the Board of Education was the consideration of a resolution abating the taxes heretofore levied for the year 2025 to pay debt service on the Taxable General Obligation School Bonds (Alternate Revenue Source), Series 2016B (Qualified School Construction Bonds), General Obligation School Bonds (Alternate Revenue Source), Series 2020A, and General Obligation Lease Obligations (Alternate Revenue Source), Series 2020C, of the District.

Whereupon Member ______ presented and the Secretary read by title a resolution as follows, copies of which were available to everyone in attendance at said meeting who requested a copy:

RESOLUTION abating the taxes heretofore levied for the year 2025 to pay debt service on the Taxable General Obligation School Bonds (Alternate Revenue Source), Series 2016B (Qualified School Construction Bonds), General Obligation School Bonds (Alternate Revenue Source), Series 2020A, and General Obligation Lease Obligations (Alternate Revenue Source), Series 2020C, of School District Number 131, Kane County, Illinois.

WHEREAS, the Board of Education (the "Board") of School District Number 131, Kane County, Illinois (the "District"), by resolution adopted on the 1st day of August, 2016, as supplemented by a Notification of Sale of Bonds, dated August 3, 2016 (the "2016B Resolution"), did provide for (i) the issue of \$15,500,000 Taxable General Obligation School Bonds (Alternate Revenue Source), Series 2016B (Qualified School Construction Bonds), of the District (the "2016B Bonds") and the levy of a direct annual tax sufficient to pay the principal of and interest the 2016B Bonds, and (ii) the establishment of a bond fund for the repayment of the 2016B Bonds (the "2016B Bond Fund"); and

WHEREAS, the Board by resolution adopted on the 21st day of January, 2020, as supplemented by a Notification of Sale of Bonds, dated February 12, 2020 (the "2020A Resolution"), did provide for (i) the issue of \$30,990,000 General Obligation School Bonds (Alternate Revenue Source), Series 2020A, of the District (the "2020A Bonds") and the levy of a direct annual tax sufficient to pay the principal of and interest on the 2020A Bonds and (ii) the establishment of a bond fund for the repayment of the 2020A Bonds (the "2020A Bond Fund"); and

WHEREAS, the Board by resolution adopted on the 21st day of January, 2020, as supplemented by a Notification of Sale of Obligations, dated June 11, 2020 (the "2020C Resolution" and together with the 2016B Resolution and the 2020A Resolution, the "Resolution"), did provide for (i) the issue of \$11,685,000 General Obligation Lease Obligations (Alternate

Revenue Source), Series 2020C, of the District (the "2020C Obligations" and, together with the 2016B Bonds and the 2020A Bonds, the "Obligations") and the levy of a direct annual tax sufficient to pay the principal of and interest on the 2020C Obligations and (ii) the establishment of a bond fund for the repayment of the 2020C Bonds (the "2020C Obligation Fund" and together with the 2016B Bond Fund and the 2020A Bond Fund, the "Bond Fund"); and

WHEREAS, the Board has determined and does hereby determine that funds in the amount of \$3,655,625 are available and on deposit in the Bond Fund and funds in the amount of \$580,275 are expected to be received as a subsidy credit payment from the Internal Revenue Service related to the 2016B Bonds (together, the "Available Funds") and that it is necessary and in the best interests of the District that the Available Funds be used to pay principal of and interest on the Obligations; and

WHEREAS, the Board has determined and does hereby determine that the Available Funds are in an amount sufficient to pay the principal of and interest on the Obligations when due, so as to enable the abatement of the Pledged Taxes (as defined in each Resolution) levied for the same; and

WHEREAS, it is necessary and in the best interests of the District that the taxes heretofore levied for the year 2025 to pay principal of and interest on the Obligations be abated:

Now, Therefore, Be It and It is Hereby Resolved by the Board of Education of School District Number 131, Kane County, Illinois, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this resolution are full, true and correct and does incorporate them into this resolution by this reference.

Section 2. Abatement of Tax. The Pledged Taxes levied for the year 2025 in each Resolution are hereby abated in their entirety, and the amount of the Pledged Taxes levied in each

Resolution for the year 2025, the amount of the Pledged Taxes to be abated for said year and the remainder of the Pledged Taxes levied which is to be extended for said year are as follows:
