Superintendent Rappold stated that Stephanie Holton has her completed endorsement along with 1 year experience. Heidi DuBray will finish mid-year next year with her principal endorsement. Mr. Bremner asked what other background experience Stephanie Holton had. Superintendent Rappold stated Special Education teaching and Elementary Education. Mr. Bremner also asked why the Elementary Assistant Principals salary was lower than the High School Assistant Principals when they have the same qualifications? Superintendent Rappold informed him the adoption of the principal's salary schedule at the end of April had six lanes.
