613 GRADUATION REQUIREMENTS

[Note: The requirements set forth in this policy govern the graduation standards that Minnesota public schools must require for a high school diploma for all students.]

I. PURPOSE

The purpose of this policy is to set forth requirements for graduation from the school district.

II. GENERAL STATEMENT OF POLICY

It is the policy of the school district that all students must pass the Minnesota Graduation Basic Standards tests or the Minnesota Comprehensive Assessments Second Edition (MCA-II's) per state requirements or higher guidelines and must satisfactorily complete, as determined by the school district, all course credit requirements and graduation standards, as established by the school board, in order to graduate.

III. DEFINITIONS

- A. "Course credit" is equivalent to a student's successful completion of an academic year of study or a student's mastery of the applicable subject matter, as determined by the school district.
- B. "Department" means the Department of Education.
- C. "Unit" means a unit measuring education achievement based on successfully completing the requirements of a given course of study.
- D. "Section 504 Accommodation" means the defined appropriate accommodations or modifications that must be made in the school environment to address the needs of an individual student with disabilities.
- E. "Individualized Education Program," or "IEP," means a written statement developed for a student eligible by law for special education and services.
- F. "Limited English Proficient" or "LEP" student means an individual whose first language is not English and whose test performance may be negatively impacted by lack of English language proficiency.

IV. TEST ADMINISTRATOR

The district curriculum director shall be named the school district test administrator. Said person shall be in charge of all test procedures and shall bring recommendations to the school board annually for approval.

V. GRADUATION REQUIREMENTS

- A. All students must satisfactorily complete, as determined by the school district, either the basic skills requirements for students enrolled in grade 8 before the 2005-2006 school year or the MCA-II's for students enrolled in grade 8 in the 2005-2006 school year.
- B. Students beginning ninth grade in the 2004-2005 school year and later must successfully complete, as determined by the school district, the following high school level course credits for graduation:
 - 1. Four credits of language arts;
 - 2. Three credits of mathematics, encompassing at least algebra, geometry, statistics and probability sufficient to satisfy the academic standard. Beginning in the 2010-2011 school year, students must satisfactorily complete an algebra I credit by the end of eighth grade. Students scheduled to graduate in the 2014-2015 school year or later must satisfactorily complete an algebra II credit or its equivalent;
 - 3. Three credits of science, including at least one credit in biology. Beginning in the 2010-2011 school year, students scheduled to graduate in the 2014-2015 school year or later must satisfactorily complete a chemistry or physics credit;
 - 4. Three and one-half credits of social studies, encompassing at least United States history, geography, government and citizenship, world history, and economics, or three credits of social studies, encompassing at least United States history, geography, government and citizenship, and world history, and one-half credit of economics taught in a school's social studies, agriculture education, or business department;
 - 5. One credit in the arts; and
 - 6. A minimum of seven elective course credits.
 - 7. An agriculture science course may fulfill a science credit requirement to the specified science credits in biology and chemistry or physics under Section V.B.3. above.
- C. All students must satisfactorily complete the following required and elective standards, in accordance with the standards adopted by the school district:

- 1. School District Standards, Health and Physical Education (K-12);
- 2. School District Standards, Vocational and Technical Education (K-12); and
- 3. School District Standards, World Languages (K-12).
- D. Academic standards in health, physical education, world languages, and vocational and technical education will be reviewed on a periodic basis.
- E. All students must satisfactorily complete the following required Graduation Standards:
 - 1. Commencing with the 2003-2004 school year, all students entering the ninth grade must satisfactorily complete the following Minnesota Academic Standards, in accordance with the standards developed by the Department of Education :
 - a. Minnesota Academic Standards, Language Arts K-12 (2003);
 - b. Minnesota Academic Standards, Mathematics K-12 (2003);
 - c. Minnesota Academic Standards, Science K-12 (2004);
 - d. Minnesota Academic Standards, Social Studies K-12 (2004); and
 - e. Minnesota Academic Standards, Arts K-12 (2003);

[Note: Beginning in the 2010-2011 school year, students will be required to satisfactorily complete revised Minnesota Academic Standards and high school graduation requirements in the arts. Beginning in the 2012-2013 school year, students will be required to satisfactorily complete revised Minnesota Academic Standards and high school graduation requirements in language arts. Beginning in the 2013-2014 school year, students will be required to satisfactorily complete revised Minnesota Academic Standards and high school graduation requirements in social studies.]

or

- a. Minnesota Academic Standards, Social Studies K-12 (2004), or have met the requirements of an IEP, a Section 504 accommodation plan, or alternative learning center;
- b. Minnesota Academic Standards, Arts K-12 (2003), or have met the requirements of an IEP, a Section 504 accommodation plan, or alternative learning center; and

- c. Alternative standards established in the student's individualized education program in the academic areas of language arts, mathematics and science.
- 2. Students who entered the ninth grade in or before the 2002-2003 school year may elect to complete the graduation requirements in effect when they entered the ninth grade in lieu of the Minnesota Academic Standards listed above.

VI. NOTICE

The school district will notify students and their parents of the school district's graduation requirements within 30 working days of a student's entry into ninth grade. The school district also will notify students in grades 9-12 in 2003-2004 or who transfer into the district and their parents of the school district's transition to the course credit system and options for students in grades 9 and above in 2003-2004 regarding locally established graduation requirements within 30 working days.
