- 1. The 2025 Payable 2026 Preliminary Levy Limitation totals \$3,557,040 (estimated maximum, not final amount)
- 2. The 2024 Payable 2025 Levy was \$3,345,589,28
- 3. This is an increase of \$211,451.59 or 6.32%
- 4. The potential
 - a. Increase in the general levy largely the results of adjustments from MDE. The number of these adjustments is down from prior years.
 - b. Increase in general debt service levy The small increase in Long-Term Facility Maintenance is due to the Track and Field project
