This RFP was advertised as a single-awarded contract starting on July 1, 2024, until June 30, 2025, with an option to extend for four additional one-year terms with the same terms and conditions if mutually agreed upon by district and vendor. Two proposals were received. A committee reviewed all proposals, and the recommendation is to award **Southwest Foodservice Excellence** the contract offering the best value for the district.

RFP 23-021 Spirit Logo and Merchandise

Request for Proposals for Spirit Logo and Merchandise was advertised in the Boerne Star and on the Boerne ISD website. This RFP was advertised as two separate contracts. The first contract is for a single-awarded vendor to supply and sale Logo Merchandise for Onsite Events and at the Athletic Office Store for a percentage of gross sales returned to the District for merchandise sold. This contract will start on July 1, 2024, until June 30, 2025, with an option to extend for four additional one-year terms with the same terms and conditions if mutually agreed upon by district and vendors. Five proposals were received with vendors offering various levels of commissions returned to the District. A committee reviewed all proposals, and the recommendation is to award **WODBOM TX dba Sherpa Werks** the contract offering the best value for the district. The second component of the Spirit Logo Contract is to offer vendors the opportunity to produce and sale Logo Merchandise from their physical location of business for a set fee paid to the District of \$5000. Three Vendors have submitted proposals for this contract, **Custumm Design & Tees, Gunpowder & Cabernet, and McAdams Holdings LLC dba Mac Wylie Golf Center**. This is a one-year contract that will start on July 1, 2024, and end on June 30, 2025.

A committee reviewed all proposals, and the recommendation is to award **Ford of Boerne** the contract offering the best value for the district.

Request for Proposals for Child Nutrition Paper and Café Supplies was advertised in the Boerne Star and on the Boerne ISD website. This RFP was advertised as a multi-awarded contract starting on July 1, 2024, until June 30, 2025, with an option to extend for four additional one-year terms with the same terms and conditions if mutually agreed upon by district and vendor. Four proposals were received. Each proposal received was complete with vendors offering various levels of discounts and incentives. The recommendation is to award multiple vendors in order to secure the best value for the district. This will provide negotiable pricing options for all campuses/departments and will supply Boerne ISD a multi-award vendor list. Awarded vendors are **Quill LLC, Sysco Central Texas, The Masters Distribution Systems, and UniPak.** In addition to these vendors, the district may also seek pricing from Vendors on approved inter-local co-op lists, with the goal of obtaining the best value for the district.
