Meeting Minutes

1. Call to Order / Attendance

The public meeting of the Madison Board of Education was called to order by Chair Seth Klaskin at 7:30 p.m. Mr. Klaskin led the Pledge of Allegiance.

2. School / Community Session

Eva Van Camp 29 Bridle Path Lane

Captain Van Camp addressed the Board requesting a waiver for reduced tuition so that her children can remain in the Madison Public Schools. She is currently the Commander of the United States Coast Guard, Sector Long Island Sound and will be transferred to the Coast Guard Academy in New London in the summer of 2023. She will be required to live on campus when the relocation takes place. Captain Van Camp spoke highly of the school district, to the positive experiences her children have had and their desire to remain in their schools (Polson and Ryerson).

3. Board of Education Student Representatives' Report Lucy Fritzinger and Eli Ackerman

Eli reported Trimester 1 just finished and the consensus is that exams went well. The fall play just wrapped up and the Jazz, Band and Chamber ensemble concerts are coming up. Blood drive scheduled for December 20. Lucy reported next week is spirit week, with a pep rally on Friday, December 23 (1/2 day). Winter sports have begun; girls basketball had an away game today. Boys basketball has their State championship ring ceremony next Friday right before their home game against Guilford.

4. Superintendent's Report Craig A. Cooke, Ph.D.

Dr. Cooke and Assistant Superintendent Gail Dahling-Hench presented a draft GANTT chart which is being used as a planning and tracking tool for the new school building project. Dr. Cooke presented the proposed 2023-2024 school year calendar, noting teachers will start on August 24 and students will start on August 29 with the last day scheduled for June 10 (182 school days and 6 PD days). This calendar has been shared with school administration, the PRC (Parent Representative Council) and the MEA. A parent request to have the day after

Halloween as a PD day will not take place, in order to maintain the Board's policy and practice of trying to schedule as many uninterrupted school weeks during the fall as possible. A number of students from Polson Middle School wrote letters requesting April 8, 2024 as a day off of school in order to travel to view the solar eclipse. Staff members requested that day be part of the April break, which is, in fact, scheduled for April 8-12, 2024. The Accountability Report was recently released and will be presented at the February. 7, 2023 meeting. DHHS, Ryerson and Jeffrey were named schools of distinction. Dr. Cooke noted there are 126 schools of distinction in Connecticut, three of which are in Madison.

This has taken place over the past two months and the Board of Selectmen is likely to recommend this for the Police Department payroll. A DHHS senior attended tonight's MYFS meeting and spoke to the "Ted Talk" project she is working on in conjunction with Principal Salutari.
