# ■ UHS Information Security

#### *New protocols/policies implemented:*

- In accordance with action items associated with the Audit Findings identified through the Schneider Downs Cybersecurity Audit, including the centralization of the UHS Information Security Program, we are continuing to implement various new protocols across all of the UHS universities.
- Several Information Security UH MAPPs were elevated to SAMs during the last policy review process including: SAM 07.A.10 (Information Security Program) and SAM 07.A.11 (Information Security Incident Reporting and Investigation).

# *New compliance-related training:*

• The Secure Our Systems cyber security training for faculty and staff was modified to comply with new requirements defined in HB 3834 passed by the Texas Legislature during the last session. Additional actions will be taken during the next six months to address additional new requirements contained in the legislation.

Between July 1, 2019 and September 30, 2019, a total of 29 inquiries were reported to UHS Information Security. The breakdown of reports by campus is as follows: UH Victoria 15, UH Downtown 4, UH Clear Lake 2, UH 8. Four of the reports were determined to be security incidents.
- Digital Millennium Copyright Act (DMCA) notices: 39 complaints were received during the quarter. This compares with 41 in the same quarter in 2018, 76 in 2017 and 561 in 2016 and represents the continued effectiveness of technology implementations.
- Legal Holds: Under the direction of the Office of General Counsel, UHS Information Security did not process any new litigation holds this past quarter. No litigation hold cases were closed this past quarter. There are currently 34 active litigation holds consisting of 825 GB file shares and 8 TB external hard drives.
- During the quarter, monthly information security reports were submitted to the Texas Department of Information Resources (DIR) for the UH System agency.
