Such deliberations will consider social or personal histories, disciplinary data, or the investigation of charges against the pupil, which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of the pupil referred to in such histories or data or involved in such investigation; all members present as listed above and voting in favor of convening closed session.

Adjourn Closed Session – A unanimous Kastens/Moore motion adjourned closed session to reconvene regular session; all members present as listed above and voting in favor of reconvening regular session.
