SUBJECT: CENTER CONTRIBUTION TO TRS-ACTIVECARE HEALTH CARE

FOR 2011-2012

EXPLANATION: House Bill 3343, passed by the 77<sup>th</sup> Legislature, requires education service

centers to offer eligible staff TRS-ActiveCare Health Care, effective

September 1, 2002. Eligible staff members include:

• Full-time and part-time employees who contribute to the Teacher Retirement System (working 18.75 hours/week or more and effective 2011-2012, includes employees working 15 hours/week or more with no full-time equivalent position).

Note: Employees who are not contributors to the Teacher Retirement System will be required to pay all costs of participation (regularly scheduled to work at least 10 hours but less than 18.75 hours per week and effective 2011-2012, includes employees working at least 10 hours but less than 15 hours/week with no full-time equivalent position).

In 2010-2011, the Center contribution was \$262.00 for Plan 1-HD, \$279.00 for Plan 1 and \$341.00 for Plans 2 and 3. In 2011-2012, there will be a 9.5% premium increase for Plan 1-HD, 1, 2 and 3; therefore, it is recommended that the Center contribution be increased to \$287.00 for Plan 1-HD participants, \$325.00 for Plan 1 participants, and \$379.00 for Plan 2 and Plan 3 participants, pending legislative action.
