Annual Budget for the 2021-2022 Fiscal Year

Tony Kingman, Chief Financial Officer, Dr. Marc Puig, Superintendent, Theresa Servellon, Chief Academic Officer, and Mark Sanchez, Legal Counsel, were called to present and answer questions related to this item.

Mr. Rodriguez made a motion: to accept the Superintendent's recommendation and adopt the general fund budget as presented moved to approve the item as presented, Mrs. Alderete seconded Mrs. Prado made a substitute motion: My motion is that I move that four additional roving Instructional Coaches be authorized at the Superintendent's discretion. The goal of these additional coaches would be to augment the existing coaches at each Student Success Initiative Campuses, the SSI, specifically, grade 5 reading and math and grade 8 reading and math who have demonstrated the greatest need, as identified by the STAAR 2021 results, or assigned at the Superintendent's discretion. Further, that the funding source be determined by taking 2.5% from each function in fund 199 of the proposed 2021-2022 operating budget, excluding object code 6100, for a total not to exceed \$315,000. That the total of \$315,000 be redirected to function 11, object code 6100. However, this amount may be otherwise identified at the discretion of the Superintendent, seconded by Mr. Flores, and the Board of Trustees voted 4/2 to approve. Motion passed.

#### SUPERINTENDENT'S REMARKS (NO ACTION / REPORT ONLY)

Dr. Marc Puig, Superintendent of Schools, addressed the Board and audience thanking the Board for a great start of the year and for their positive presence at Convocation. He praised Price ES teachers for collaborating to frame the lesson, Benavidez ES deep work and alignments, and Madla ES for setting up literacy stations, Athens establishing the vision and the norm with PLC's. He stated that the Executive Leadership Team me with the Toyota corporate communications department yesterday. The team had a lot to share with respect to innovation. He informed that we have a Facilities Committee meeting on August 25<sup>th</sup> and a Veterans Committee meeting on September 1<sup>st</sup>. Dr. Puig stated that we are going deeper with the vaccination efforts with respect to COVID. He stated that we are accelerating the remote learning options as well.

He stated that our districts scores are some of the lowest in Bexar county. He stated that the Board will provide the Superintendent with the tools he needs to rectify the student outcomes as soon as possible.
